Variance V-2022-20 Owner & Applicant: Maurice and Elizabeth Desmarais Lot 2 Plan 68458 37 Prairie Crescent

Purpose: To allow a rear yard set back of 18.5 feet whereas the "RLD" Residential Low Density Zone requires a minimum setback of 25 feet. The owners are planning to build an attached sunroom.
