- 1. Minutes of the Regular Council Meeting of City of Steinbach Council held on Tuesday, April 6, 2021 at City of Steinbach Council Chambers.
- 2. Mayor Earl Funk called the meeting to order at 7:30 p.m., with the following members of Council present: Councillors Jac Siemens, Damian Penner, Bill Hiebert, Michael Zwaagstra, Jake Hiebert and Susan Penner Also present: City Manager, Troy Warkentin, Manager, Corporate Services, Adam Thiessen and City Clerk, Deb Rempel.

6. Council meeting recessed and Public Hearing was called to order at 7:35 p.m., by Mayor Funk. Public Hearing was to consider Variance V-2021-03.

<u>Variance V-2021-03</u>

Owners / Applicant: Laverne & Kimberley Pappel Lot 1 Plan 49241 22 Country View Lane

- Purpose: 1. To allow 1972 square feet of accessory use whereas the "RR" Rural Residential Zone only permits a maximum of 1000 square feet.
- 6.1 Troy Warkentin, City Manager, introduced Variance V-2021-03 and reported that notices pursuant to The Planning Act had been completed.
- 6.2 There was no written correspondence to Variance V-2021-03 on file.
- 6.3 The applicants Laverne and Kimberley Pappel were present at the Public Hearing. Mr. Pappel provided that they intend to construct a building to be used as a wood workshop and storage shed. The plan includes that the 2 older buildings on the property will be removed with the new build.

The applicant was prepared to answer questions of council.

Owners / Applicant: Michael & Shannon Roeckenwagner Lot 35, Block 4, Plan 12257 55 Coral Crescent

- Purpose: 1. To allow a 1.9 foot east side yard setback whereas the "RLD" Residential Low Density requires a minimum of 4 feet.
- 8.1 Troy Warkentin, City Manager, introduced Variance V-2021-06 and reported that notices pursuant to The Planning Act had been completed. It was found that a construction error by applicant was found upon a building inspection. An addition attached to the house was constructed that did not comply with the permit issued and is too close to the property line.

- 10. Council Meeting recessed and Public Hearing was called to order at 7:50 p.m., by Mayor Funk. Public hearing was to consider the City of Steinbach 2021 Financial Plan.
- 10.1 2021 Financial Plan
- 10.2 Brian Hrehirchuk, Senior Manager, Finance, presented the 2021 Financial Plan. Mr. Hrehirchuk provided that City Council, Management and staff have been working on the budget for several months, with Council providing comments at the final review in November.
- 10.3 Mr. Hrehirchuk provided some 2021 Expenses Programs and Projects and Debt that make up the 2021 budget:
 - Waste reduction and recycling
 - Jake Epp Library
 - Summer in the City Festival
 - Beautification
 - Dutch Elm Disease prevention
 - Canada Day activities
 - Police and Fire Services
 - Transportation Services
 - Solid Waste Services
 - Recreation Services
 - Water and Wastewater Services

- Events Centre
- Road and Water service
 - Acres Drive
- Road Surface renewal
 - Park Road East
 - Penfeld Drive

- 10.4 Mr. Hrehirchuk provided that the City of Steinbach is in receipt of the Notice of Tax requirements for the Hanover School Division in accordance with Section 187 of The Public Schools Act, under Section 188 for 2020 the amount to be raised by tax levy is \$14,163,826.00.
- 10.5 Mr. Hrehirchuk provided that the City of Steinbach is in receipt of the Notice of Tax requirements for the Manitoba Education and Training 2020 Education Support Levy in accordance with sections 182 and 183 of The Public Schools Act, 2020 Other Property to be raised by tax levy is \$3,059,848.00.

- 10.6 Brian Hrehirchuk, Senior Manager, Finance, provided that the projected 2021 Municipal property tax mill rate would remain at 3.70 mills. No change from the 2020 mill rate. There is no change to utility rates, a 2.8% increase for residential garbage collection, overall 2.5% fee increase for land use applications and permits. Combined residential mill rate 27.95, combined commercial mill rate 36.759.
- 10.7 Mr. Hrehirchuk completed his presentation at 8:00 p.m.
- 10.8 Mr. Hrehirchuk was prepared to answer questions of council.
- 10.9 There was no one present with questions or concerns at the meeting.
- 10.10 Council members expressed that the mill rate remains steady. Council continues to invest in underground infrastructure, roads and pathways and continue to improve recreation opportunities.
- 10.11 Mayor Funk commented on highlights of the 2021 budget. Mayor Funk thanked Council and staff for the work they have done in preparing the budget.
- 10.12 There being no further discussion the Public Hearing closed and the Council meeting opened 8:08 p.m., and the following resolutions resulted.
