## MINUTES

1. Minutes of the Regular Council Meeting of City of Steinbach Council held on Tuesday, January 15, 2019 at City of Steinbach Council Chambers.

2. Mayor Earl Funk called the meeting to order at 7:30 p.m., with the following members of Council present: Councillors Susan Penner, Damian Penner, Jac Siemens, Jake Hiebert, Bill Hiebert and Michael Zwaagstra. Variance V-2019-01 29 Cambridge Way Owner: JEMM Ventures Ltd. Applicant: Michael and Jodi Unger

Purpose: The applicants are requesting to not complete the street edge landscaping for the property as required in Zoning By-Law 2100.

6.1 City Manager, Troy Warkentin, introduced Variance V-2019-01 and reported that notices pursuant to The Planning Act had been completed.

6.2 There is no correspondence on file.

6.3 Jodi and Michael Unger, 8 - 396 McKenzie Avenue, applicants were present at the hearing and provided the following:

- They have invested in the 16 Unit high-end pet friendly apartment complex.

- They purchased the property and drawings and site plans from the landowner and proceeded to build. In November 2018 they were informed that they had not built according to the plans that were approved by the City.

- They provided that the Development Agreement did include street edge landscaping and that this was an oversite on their behalf. They agree that green space is important and needed. They suggested they plant trees in the backyard or within the City's greenspace as a requirement. They would like to come to a solution that would be soothing to the community.

- The applicants were prepared to answer questions of Council.
