1. Minutes of the Regular Council Meeting of City of Steinbach Council held on Tuesday, May 15, 2018 at City of Steinbach Council Chambers.

7. Royal Canadian Mounted Police (RCMP); Staff Sergeant Harold Laninga appeared before Council as a delegation and provided comment on the following. 9. Council meeting recessed and Public Hearing was called to order at 7:47 p.m., by Mayor Chris Goertzen. Public Hearing was to consider Variance V-2018-06.

Variance V-2018-06 66 Edgewood Street Applicant / Owner: Theodor Sawatzky

Purpose: 1. To allow a rear yard setback of 12.35 feet whereas the "RLD" Residential Low Density Zone requires a minimum of 25 feet; and

2. To allow a shed to be within 1.8 feet of the rear property line whereas a minimum of 2 feet is required in the "RLD" Residential Low Density Zone.

The applicant constructed a sunroom on the back of the property and the addition is too close to the property line.

9.1 City Manager, Troy Warkentin, introduced Variance V-2018-06 and reported that notices pursuant to The Planning Act had been completed.
