305 Main Street

Owner: Steinbach Credit Union Society Limited Applicant: Calvary Chapel of Steinbach Inc.

Purpose: To allow ten (10) parking stalls whereas one hundred (100) parking stalls are required for a principal assembly area of four hundred at a place of worship.

- 11.1 City Manager, Troy Warkentin, introduced Variance V-2018-24 and reported that notices pursuant to The Planning Act had been completed.
- 11.2 One item of correspondence had been received from Matt Wieler, 102 Poplar Crescent, affirming support to the variance.
- 11.3 Mr. Robert Balfour, 1 Beaverbrook Drive, representing Calvary Chapel, was present at the hearing.
- -He has heard that the hockey community has concerns and is willing to work with the group. He feels that by communicating with their landlord, there should be no day time usage concerns.
- He explained that there was difficulty in creating a working definition with the City that restricts parking that wouldn't impede the proper function of the Church.
- He provided examples of being open during Summer in the City, where parking would not be needed, but their building would be open. Hosting a international Youth meeting where youth came from other places and were bussed from location to location.
 - They want to be good neighbors, and not misuse any parking stalls.

Variance V-2018-24 266 Park Road West

Owner: Paisley Investments Ltd.

Applicant: Norm Paisley

Purpose: As per Zoning By-Law 2055 all required parking stalls must be hard surfaced. To allow the required four (4) parking stalls not to be hard surfaced.
