Purpose: To Rezone the subject properties from "RHD" Residential High Density to "RMD" Residential Medium Density zone.

- 7.1 City Manager, Troy Warkentin, introduced rezoning By-Law 2155 and reported that notices pursuant to The Planning Act had been completed.
- 7.2 An item of correspondence has been received from Manitoba Municipal Relations Community Planning Branch voicing no concerns. Manitoba Municipal Relations Community Planning Branch provided that no objections or concerns were received from the commenting agencies.
